

Chair's Report

April 2012 to March 2013 has been another successful year with Haven Distribution having more funds and continuing to supply educational books & dictionaries across most of the prisons. We made the difficult decision to only provide books to people in prison who have more than 6 months still left to serve. We did so to both save money due to the cost of books and postage increasing and as a result of the large amount of returned books from prisons saying the inmate had been released. With limited resources we have to maximise our effectiveness. Indeed this has not meant a reduction in our service; in fact we have increased the amount of books going into prisons to 1,731 during the year.

In April 2012 we were very fortunate to receive a donation from the publishers Hachette UK, through their Hodder Trust, towards a project to encourage applications from prisoners. This donation was particularly appreciated as the charities that were given donations were chosen by Hodder & Stoughton staff themselves. The project has involved us carrying out research to find out why we get such a small number of applications from female prisoners, work on engaging more women with the service and, of course, supplying books. We started with HMP Holloway and have made some good links with their library staff and education manager. We have also built links with the Education Department at HMP Downview (although this prison has now closed to transfer over to a male prison). In the year since we started the project our applications from women have increased from 5 to 52. We intend to build on this success and hope to make direct links with staff at other female prisons.

Haven continues to operate without any paid employees, meaning that all the money we raise is spent on providing books to prisoners. This is an important principle for us, despite the reliance on a few key volunteers.

I would like to thank those individuals who have given their time/money to assist with Haven, Jon the Driver whose support is really appreciated and not forgetting our anonymous website volunteer for his continuous *pro bono* work.

INDEPENDENT EXAMINER'S REPORT to the Trustees of HAVEN DISTRIBUTION on the accounts for the year ended 31 MARCH 2013

I have examined the accounts on pages 2 to 5 which have been prepared on the basis of the accounting policies set out on page 4.

Respective Responsibilities of Trustees and Examiner

The trustees of the charity are responsible for the preparation of the accounts. They consider that an audit is not required for this year, under section 43(3) of the Charities Act 1993 ("the Act"), and that an independent examination is needed.

As independent examiner it is my responsibility to:

- Examine the accounts under section 43 of the Act;
- Follow the proceedures laid down in the General Directions given by the Charity Commission under section 43(7) (2) (b) of the Act;
- (3) State whether particluar matters have come to my attention.

Basis of Examiner's Statement

My examination was carried out in accordance with General Directions given by the Charity Commissioners. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the accounts.

Independent Examiner's Statement

HAVEN DISTRIBUTION NOTES TO THE ACCOUNTS YEAR ENDED 31 MARCH 2013

1) ACCOUNTING POLICIES

(A) Basis of accounting

These accounts have been prepared on the basis of historic cost and in accordance with:

- Accounting and Reporting by Charities Statement of Recommended Practice (SORP 2005)
- the Charities Act 1993

(B) Incoming Resources

Incoming Resources are included in the Statement of Financial Activities (SoFA) when the charity becomes entitled to the resources, the trustees are virtually certain they will receive the resources, and the monetary value can be measured with sufficient reliability. Legacies, grants and donations are only included in the SoFA when the charity has unconditional entitlement to the resources. Investment income is included in the accounts when receivable. Gifts in kind and donated services and facilities are not given an estimated value in the accounts. Volunteer help is not given any value in the accounts but is described in the trustees' annual report.

(C) Tangible Fixed Assets

There were no fixed assets of any material value purchased during the year or owned by the charity at the year end.

(D) Reserves & Funds

The accounts distinguish between restricted and unrestricted funds:

Restricted funds are received from donors and are subject to restrictions on the purpose for which they may be used. The costs of raising, spending and administering those funds are charged against each fund.

Unrestricted funds are those where there are no externally imposed restrictions. These include those freely available to the Charity for expenditure or appropriation to reserves for general charitable purposes.
